It takes an integrative approach to the subject of electromagnetics by supplementing quintessential "old-school" information and methods with the appropriate amount of material on plasmas for exposing the students to the broad area of Plasmonics and by striking a balance between theoretical and practical aspects. Ancillary materials are available upon qualifying course adoption.
